

## Highlights of Q2 results

- Gross sales of the Company have increased from Rs. 77.06cr. to Rs. 93.73 Cr. ( 21.63 % Growth )
- Profit Before Tax has increased from Rs. 13.32 Cr. to Rs. 14.92 Cr. ( 12 % increase)
- Profit after Tax has increased from Rs. 9.03 Cr to Rs. 10.02 Cr. ( 11 % increase )
- Earnings per share has gone up from 6.18 of last year to 6.88 ( 11 % increase

### OTC Division

- Gross sales of OTC have increased from Rs. 65.99 cr. To Rs. 81.36 Cr. (Increase of Rs. 15.37 Cr out of which Rs. 13.21 Cr. came from Volume growth). 23.29% Growth out of which volume growth is 20.02 %
- Volume of 302.26 Tons. Sold in H1 of 2016-17 as against 250.44 Tons during H1 of 2015-16.

### Fruitnik Division

- Gross Sales increased from Rs. 11.14 Cr. to Rs. 12.46 Cr. for YTD Sep ( 11.85 % increase over last year same period )
- ATL Spend has been increased from Rs. 24 Lakhs to Rs. 78 lakhs.
- Fruitnik division sales is lower than expected in H1 as the Eastern region plant came online later than the expected time line.

## The salient point of the Outcome of the Board Meeting

The Company have been paying dividend twice a year so far and It has been decided to distribute the dividend across the year paying interim dividend more than once preferably every quarter. It has been decided to pay Rs. 1.10 per share of face value Rs. 2.00 as interim dividend with the book closure date as 18<sup>th</sup> November 2016.
