With reference to the above, we hereby inform you that the present Statutory Auditor of the company – M/s Haribhakti & Co. LLP, Chartered Accountants have resigned as Statutory Auditor of the Company with immediate effect vide their letter dated 11th June 2018.

As per the discussions with the Statutory Auditor, due to a proposed internal restructuring in the Audit Firm, the Company has opted for an early rotation. While the Statutory Auditor has completed their audit for the financial year 2017-18 and has submitted their report thereon to the Board of Directors of the Company, the timing of their resignation is only to enable the incumbent Statutory Auditor a smooth transition, audit and reporting from the first quarter of the financial year 2018-19. M/s Haribhakti & Co. LLP have conveyed their No Objection in appointing another Statutory Auditor of the company for the Financial Year 2018-19 vide their letter dated 11th June 2018.

A meeting of the Audit Committee of the Board and that of the Board of Directors will be called shortly to take on record the resignation of Auditor and to appoint new Statutory Auditor in the casual vacancy pursuant to the provisions of Section 139(8) of the Companies Act, 2013. The casual vacancy caused by resignation of the Statutory Auditor will be filled by the Board within the stipulated time limit, subject to the approval of the company in the ensuing General Meeting within three months.

A copy of the resignation received from the Auditor is attached herewith for your kind reference. Kindly take the same on record.
