Sub.: Intimation of development in arbitration proceeding pertaining to TSGENCO contract

Ref.: Regulation 30 of the SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015

This is to inform that, in the arbitration proceedings pending before the Hon'ble Justice (Retd.) Madan B. Lokur, who was appointed as a Sole Arbitrator by the Hon'ble Supreme Court of India, the Hon'ble Sole Arbitrator has upheld the contention of Telangana State Power Generation Corporation Limited ("TSGENCO"), VA Tech Wabag Limited ("WABAG") and Gammon Engineers and Contractors (P) Limited ("GAMMON") stating that the individual consortium member, in this case, Tecpro Systems Limited ("TECPRO") cannot invoke the arbitration against the employer, in this case, TSGENCO.

The Sole Arbitrator vide order dated November 07, 2023 held that the claims filed by TECPRO against TSGENCO were rejected/disallowed, the arbitration proceedings against WABAG and GAMMON are not maintainable and no relief has been claimed against WABAG and GAMMON by TECPRO.

The above said arbitration was relating to a dispute that arose out of the contract executed between TSGENCO and the consortium of TECPRO, WABAG and GAMMON. In this case, TECPRO without the consent of other consortium members, in violation of the consortium agreement, invoked the arbitration against TSGENCO which was objected by, TSGENCO along with WABAG and the other consortium member GAMMON.

By virtue of this order, WABAG as the consortium leader is entitled to receive approximately INR 140 Crores (Indian Rupees One Hundred and Forty Crores only), which was under hold by TSGENCO due to pendency of this arbitration proceeding. The details required to be disclosed pursuant to the circular issued by the SEBI bearing the reference no. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023 are provided as **Annexure-A** below.
