- Issuance of shares by MEBL to all the shareholders of AABL as per the swap ratio
- Proposed Scheme subject to approvals by shareholders, creditors, stock exchanges, SEBI**, NCLT*, RD*** and RoC****, etc.
- MEBL to be listed on National Stock Exchange of India Limited (NSE) and BSE Limited (BSE) following the Scheme coming into effect

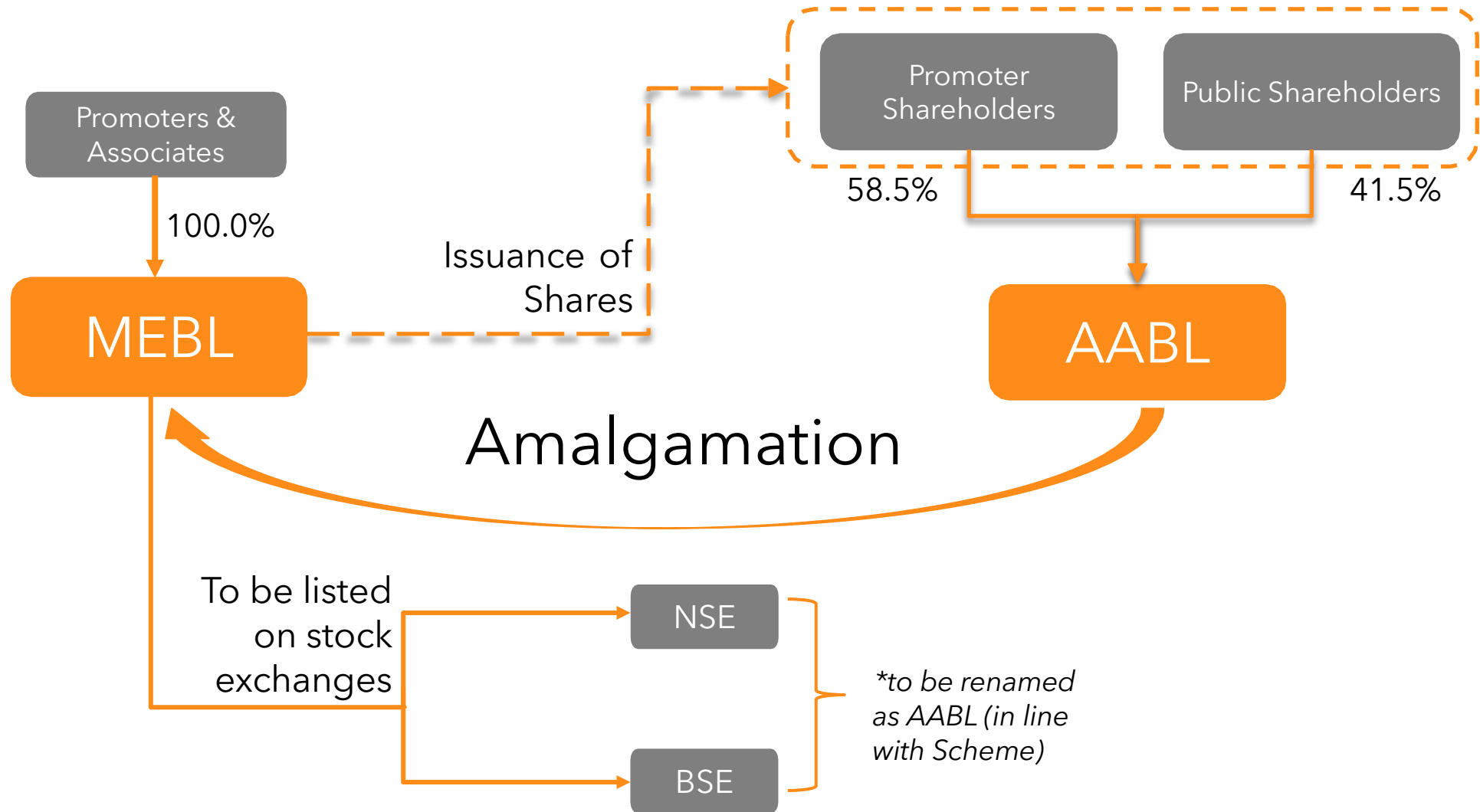
RATIONALE OF THE PROPOSED AMALGAMATION

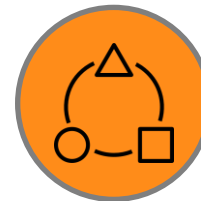
