Sub: Proposed Directions u/s 33A of the Water (Prevention & Control of Pollution) Act, 1974 and/or u/s 31A of the Air (Prevention & Control of Pollution) Act, 1981 and read with the Hazardous Waste (Management, Handling & Transboundary Movement) Rules, 2016.

WHEREAS, you are operating your industry in Water & Air pollution prevention area declared under Water (P&CP) Act, 1974 Air (P&CP) Act, 1981 and Hazardous & Other Waste (Management & Transboundary Movement) Rules, 2016. AND WHEREAS, Board has granted consent to your industry subject to certain terms & conditions therein for necessary compliances.

AND WHEREAS, it is obligatory on your part to comply those conditions and provide necessary water & air pollution control devices and operate them continuously and efficiently so as to meet the standards prescribed by the Board at all times. Also comply with the Hazardous & Other Waste (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Sub-Regional Officer MPC Board Tarapur-I and Survey team has reported that, 1) You have not provided air pollution control system (scrubber) to Nitroxynil manufacturing reactors, 2) The scrubber attached to O₂-glass lined reactors is not in working condition, 3) Pump found removed and stack attached to scrubber without any sampling arrangements, 4) You have not provided air pollution control system to centrifuge, 5) The emissions are vented off directly into environment & pungent odor is felt within premises. 6) The records of hazardous waste category i.e. spent solvents generated and disposed off is not maintained & the disposal of spent solvents is very less as compared with consented quantity, 7) You have not maintained the records of disposal of HDPE drums, carboy, MS drums & contaminated plastic bags and also the same is not disposed regularly, 8) You have not provided adequate air pollution control system comprising of bag filter /wet scrubber to stack attached to boiler, 9) You have not provided sampling arrangements i.e port, platform & Ladder are provided to stack attached to boiler, 10) You have failed to comply with Proposed direction issued on 05/02/2020 i.e not provided OCEMS to stack and ETP.


AND WHEREAS, the above fact shows gross violation of consent conditions and clearly indicates your negligent attitude towards aspect of pollution control and Environment protection.

NOW THEREFORE, in exercise of the powers conferred upon me by the Board under section 33A of the Water (P&CP) Act, 1974 and under section 31 of the Air (P&CP) Act, 1981, I, hereby direct you as follows:

- a. **Your existing Bank guarantee (BG) of Rs. 50,000/- stands forfeited and you are directed to submit a separate BG Rs. 1.0 lakhs towards compliance of these directions within 15-days.**
- b. You are directed time targeted action plan towards compliances of directions.
- c. Why your industry shall not be directed to close down its manufacturing activity forthwith & Environment compensation charges shall be imposed?
- d. Why the competent authority shall not be directed to disconnect water/ electricity supply to your unit?
- e. Why legal action shall not be initiated against you for violation of the provisions of the aforementioned Acts?

You shall submit reply to this direction and documents you want to rely upon within **7-days**, failing in which legal action will be initiated which may result in closure of your unit, which please note.
