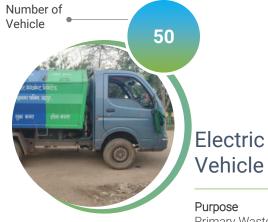

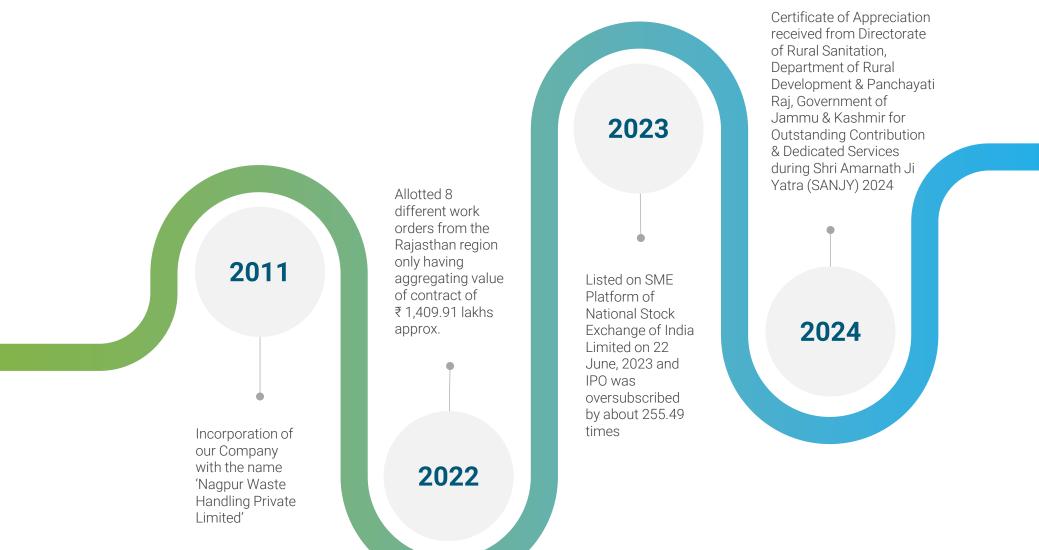

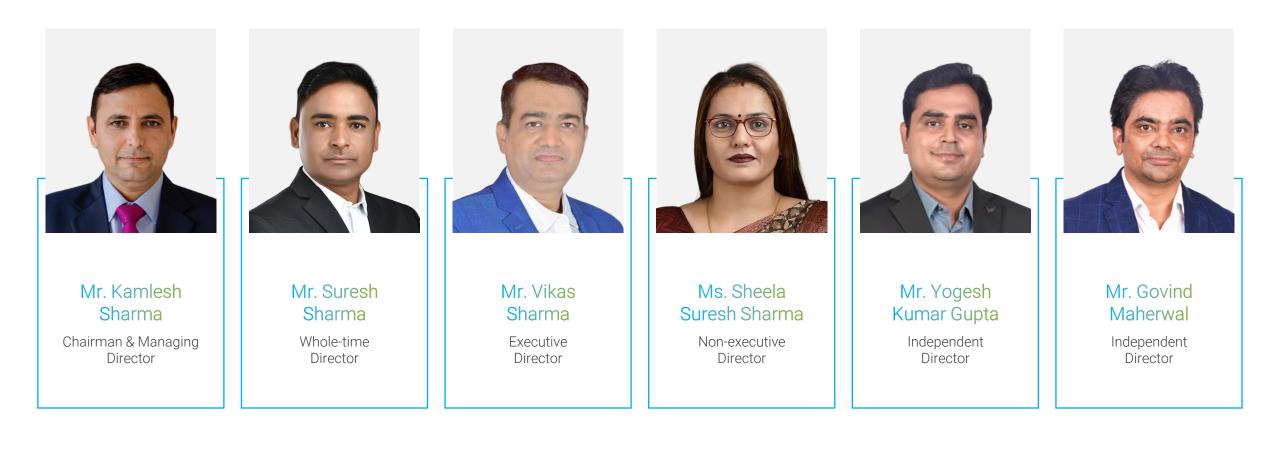

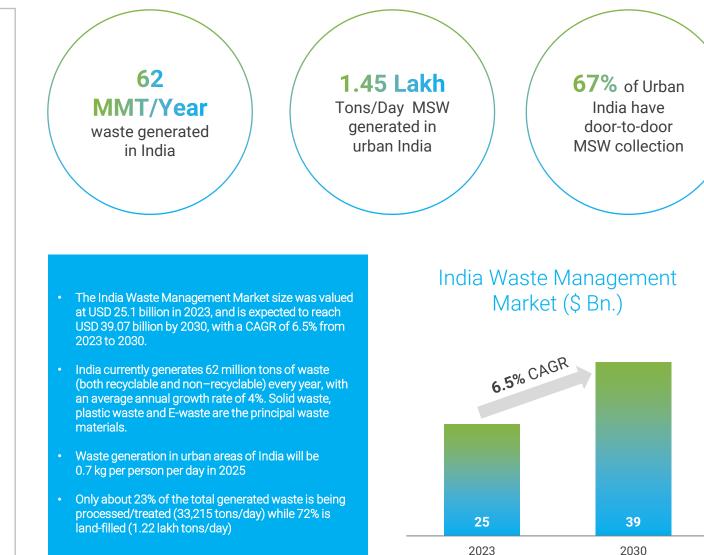

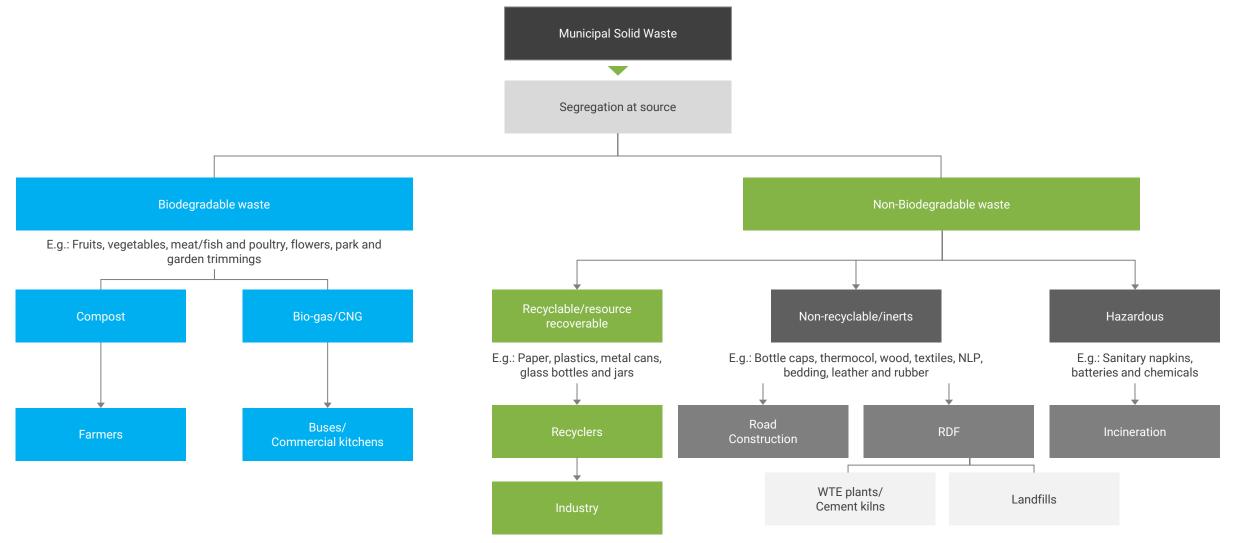

Components of MSW management – different types of waste and where they end up

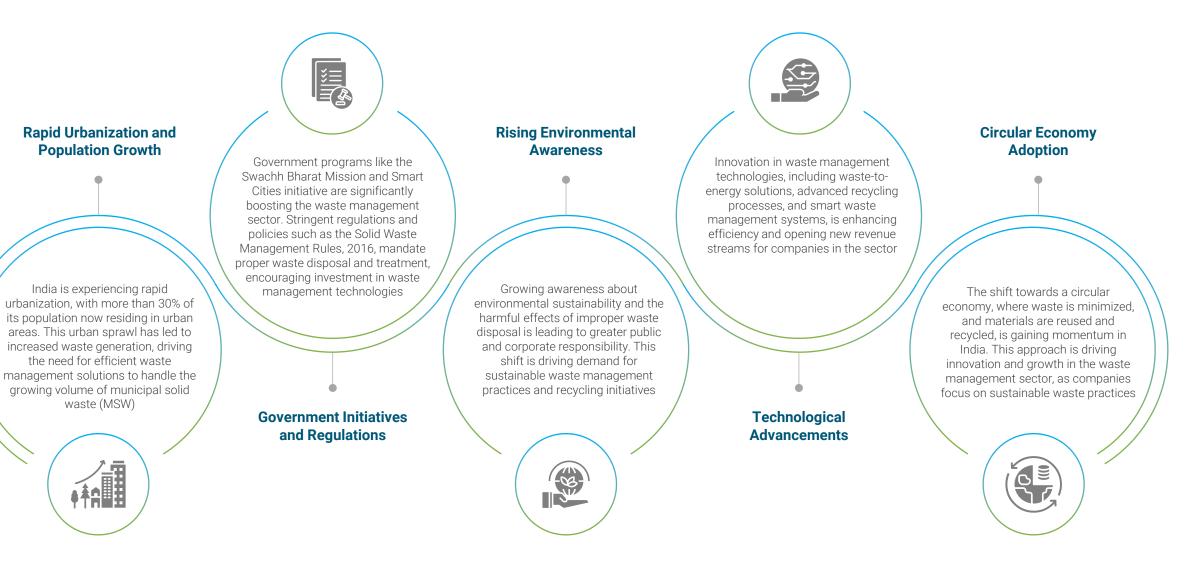

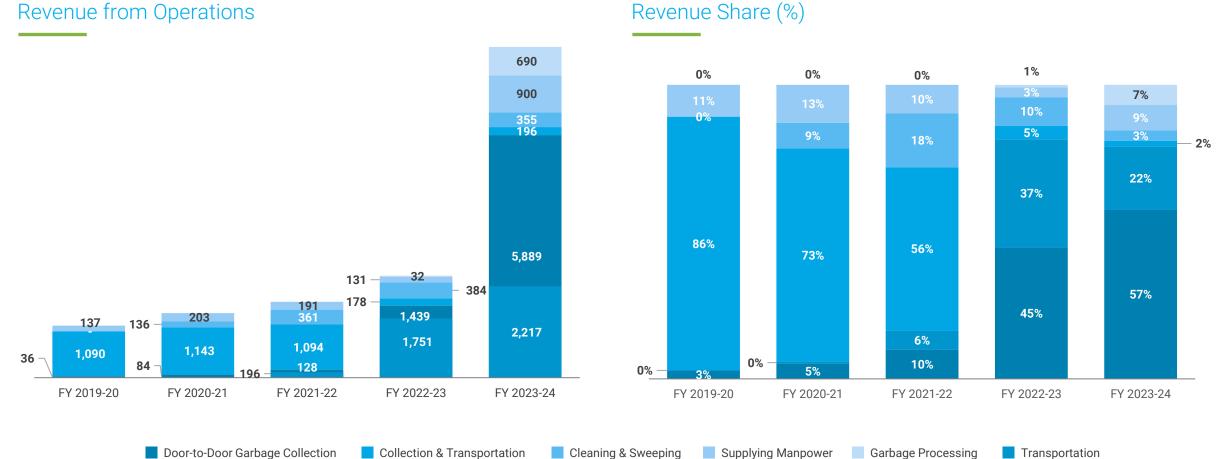

Revenue from Operations

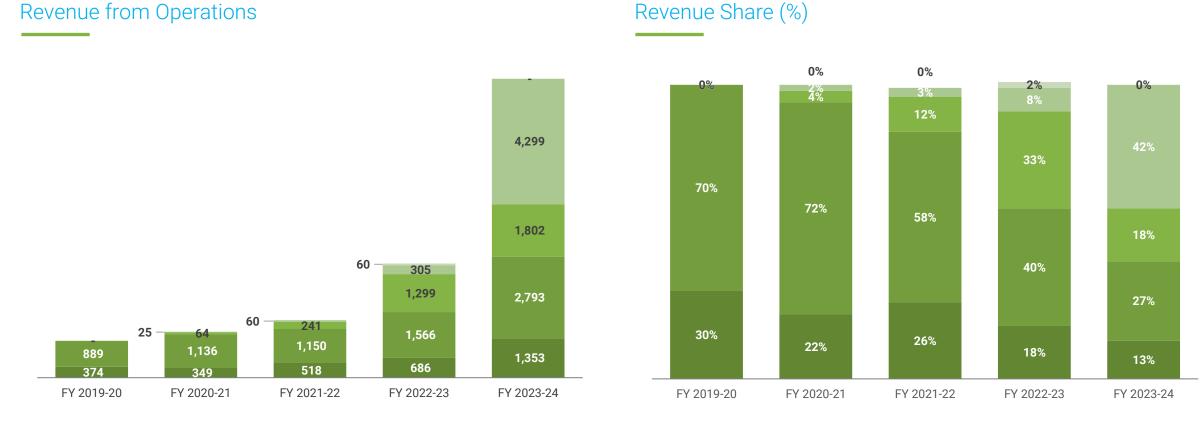

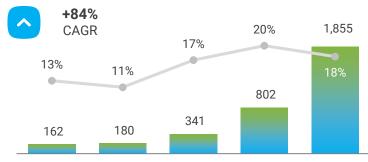

Revenue from Operations

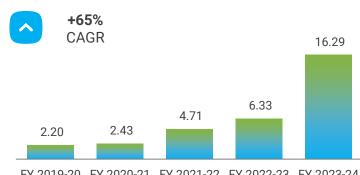


EBITDA & EBITDA Margin



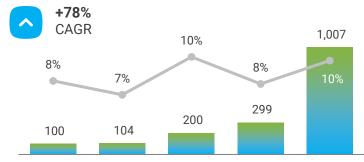

Earnings Per Share



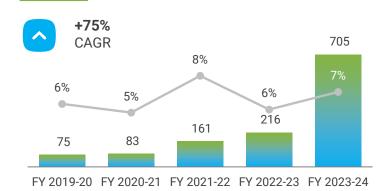

PBT & PBT Margin

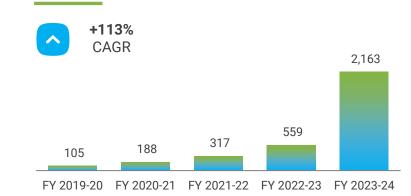

PAT & PAT Margin



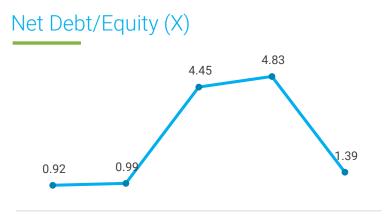




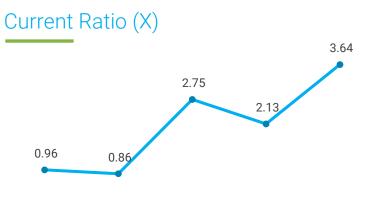

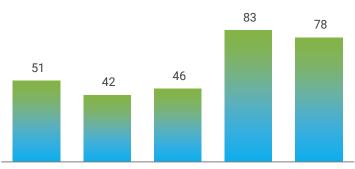

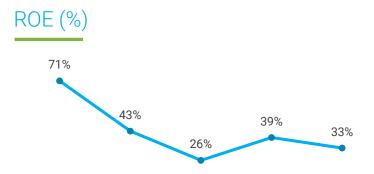

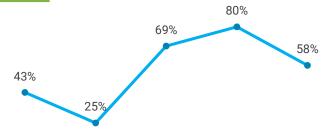

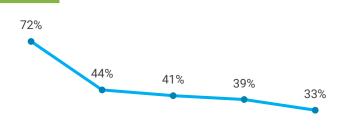

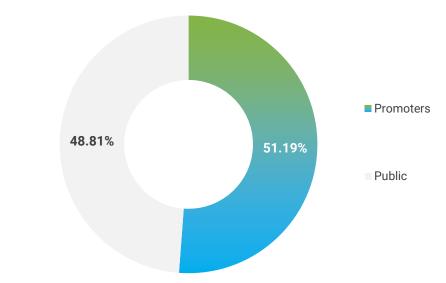
