Revision in criteria and replacements in Indices

The Index Maintenance Sub-Committee (IMSC) of NSE Indices Limited has decided to make the following changes in various indices as given hereunder.

1. Revision of criteria for NIFTY 500, NIFTY 100 and NIFTY Midcap 150 indices
