Matter is taken up today and the proceedings are conducted through physical hearing as per Order No. 35/RG/DHC/2021, dated 14.01.2021 of Hon'ble High Court of Delhi and Circular No. Power Gaz./RADC/2021/799-886-D/35-B, dated 16.01.2021.

ED has filed an application seeking 14 days judicial custody remand of accused Anoop Gupta.

Heard. Accused is remanded to judicial custody till 25.02.2021.

Ld. Counsel for accused has moved an application for permitting the accused Anoop Gupta to carry spectacles, medicines and Clothes in custody.

The jail authority may permit the accused to take medicines with him subject to the advice of the jail doctor. The accused is permitted to carry spectacles and clothes as per jail rules.

Ld. Counsel for accused has moved another application for permission to have home cooked vegetarian gluten free food. Ld. Counsel for accused submits that applicant/accused is suffering from number of ailments and doctor has advised him gluten free food. Ld. Counsel for accused submits accused is 61 years of age and needs extra bedding for sleep. Ld. Counsel for accused has filed medical record and prescription of accused.

The jail authority may consider the request of accused as per jail rules considering his medical condition.

One other application has been filed by accused Anoop Gupta for arrangement of western seat. Ld. Counsel for the accused submits that accused has severe backache and he needs

mattress, orthopedic belt and orthopedic cushion.

The Jail Authority may permit the accused to carry mattress, orthopedic belt and orthopedic cushion subject to jail rules. The jail authorities may make arrangement of western seat as per jail rules considering the medical condition of accused. Let the Medical record and prescription of accused be sent to jail along with this order.

Ld. Counsel for accused has also filed an application for permitting the accused to have legal interview with his advocate during custody period for two hours in a day.

Ld. Counsel for the accused submits that he is withdrawing his application for permitting the accused to have legal interview with his advocate and he will file the appropriate application as and when needed.

The application of accused is dismissed as withdrawn.
